### DEFINITIONS

- a) Society Means : **BLESS SOCIETY OF RURAL AND URBAN DEVELOPMENT**
- b) General Body Means : The general body comprising of all the valid members under the rules & regulations.
- c) Member Means : A person who has attained the age of 18 years, fulfilled all the condition of the society & who is enrolled & declared as a member of the Society.


### 2. MEMBERSHIP:

- a) Membership of the Society shall be open to the persons of age above 18 years & Institutions represented by persons who subscribes to the aims & objects of the Society & agree to abide these rules thereof.
- b) Every member should strictly abide by the constitution, rules & regulations.
- c) Every member has the right to participate in all the activities of the Society in accordance of the constitution.
- d) Every member having sound mind & has attained the age of 18 years and above & has been declared as member of the Society & who is not convicted for any act of offence has right to vote
- e) An individual member has to contribute Rs.101.00 & Institutional member has to contribute Rs.501.00 as membership fee.
- f) Member who has once contributed the membership fee / donation is not refundable under any circumstances. & also not entitled to transfer in the name of any other persons / member. However the management committee of the Society reserves the right either to accept or reject anybody's membership.
- g) The admission to the membership can be done on an application along with the prescribed fees and recommended by any two members of the management committee of the Society & accepted by the management committee.
- h) The members shall be ceased or cancelled in case of death or involved in any crime
- i) A member can retire voluntarily from the membership by giving a written resignation to the Secretary.



## CONSTITUTION OF THE GENERAL BODY / SPECIAL GENERAL BODY:

- a) The General body of the Bless Institute of Rural and Urban Development shall consist of all members.
- b) The General body shall meet once a year or in the middle if necessary for transacting the following subjects
- c) To consider and adopt the report of the activities of the Bless Institute of Rural and Urban Development during the past year / coming year and the audited accounts and balance sheet relating to the year under report.
- d) To elect the office bearers & Members of the managing committee.
- e) To review the progress and to adopt resolution thereon including amendment of rule and regulations.
- f) It is the policymaking Body of the Society and gives approval & ratification for the projects, Annual Plans & reports, Budgets & expenditures of the Society.
- g) Only the Special General Body has powers to dissolve the Society and bring in any amendments in Bye-Law of the Society with the approval of 3/4th majority.

## 4. CONSTITUTION OF THE BOARD OF MANAGEMENT :


The management of all matters connected with the Bless ~~Society~~ of Rural and Urban Development shall be managing committee. The managing committee shall consist of the President, Vice president, Secretary, Joint Secretary & other <sup>2</sup> members <sup>of total</sup>

- a) The managing committee of Bless Institute of Rural and Urban Development shall have all the powers to implement the aims and objects of the Bless Institute of Rural and Urban Development including monetary transactions and administration.
- b) The term of office the managing committee of Bless Institute of Rural and Urban Development Shall be one year
- c) The Managing Committee of the Society reserves the rights to constitute / form Project Management Committee & other committees as required to discharge the objectives of the Society


## 5. MEETINGS :

- a) The general body shall meet once a year with 21 days notice with agenda or in the middle of the year if necessary.
- b) The managing committee of Bless Institute of Rural and Urban Development shall meet at least once in a three months or in the middle if necessary.
- d) At least 7 days notice together with the agenda shall be given for Managing Committee meeting.
- e) The quorum for a Managing Committee meeting shall be 6 members.
- f) The quorum for G.B / Special G.B Meetings shall be  $\frac{3}{4}$  of the total members. In case quorum is not formed with in  $\frac{1}{2}$  hours the meeting will be adjourned, after 1 hour, the members present in the adjourned meeting shall form the quorum.

### Joint Secretary

If the Secretaryship becomes vacant/absent in the meeting/in the middle of the year the Joint-Secretary shall act as Secretary for the time being or until new election of the Secretary. He / She should also assist in the day to day working of the Society to the Secretary.

*Treasurer: The Treasurer shall be responsible for the issue of receipts & vouchers for the Treasurer shall be in charge of all collected fund and audited for the same funds and audited the same.*

### BANKERS:

- The managing committee is authorised to open & operate Bank accounts with any Nationalized Banks, financial institutions & any co-operative Banks/ financial institutions in India & outside India in the name of the Society.
- The managing committee of Bless Institute of Rural and Urban Development shall decide upon the bankers of the Society from time to time.
- All accounts of the Bless Institute of Rural and Urban Development with the Bank or Banks shall be operated upon by joint signature of any two of the four, the President, Vice President, Secretary and the Joint Secretary.

### BORROWINGS & FUNDS OF THE SOCIETY:

- The Society can borrow money from any Bank / Financial Institution if required, to achieve any of its aims or objects of the Society through its office bearers after suitable resolution passed in its managing committee meetings.
- The Society also can receive money from any organization/ international funding agencies for any project work commensurate with its objectives after suitable resolution passed in its managing committee meetings.
- To receive donations, Grants, Contributions and funds from State Govt. Central Govt., Individuals, Members, Organizations.


